Additionally, courses from the Master's programme in Architecture and Urban Planning like digital and creative courses (arts, painting, photography) and excursions of all study programmes are available in German and English language as well. Students can choose modules in English also at the Faculty of Civil Engineering and Geodetic Science from the study programme Water Resources and Environmental Management (limited number of places).
