The Faculty Council of the Faculty of Law of Gottfried Wilhelm Leibniz Universität Hannover on 18.01.2013 resolved the following placement regulations for the degree programme Erasmus Mundus, Master of European Legal Practice LL.M. Joint Degree (ELPIS II). The Presidential Board approved the regulations on 30.01.2013. These regulations shall take effect on the day following publication in the official bulletin of Gottfried Wilhelm Leibniz Universität Hannover.

#### Placement regulations of the degree programme ERASMUS MUNDUS Master of European Legal Practice LL.M. Joint Degree (ELPIS II) of 20.02.2013

### Section 1

### Scope of the Placement Regulations

(1) These placement regulations apply to the degree programme ERASMUS MUNDUS Master of European Legal Practice LL.M. Joint Degree (ELPIS II) at the Faculty of Law of Gottfried Wilhelm Leibniz Universität Hannover in consortium with

- the Faculdade de Direito da Universidade de Lisboa (public university Lisbon)

- and the Faculté de Droit, de Sciences Economiques et de Gestion, Université de Rouen.

(2) The placement regulations complement the examination regulations for the master's degree programme ELPIS II. In the case of inconsistencies between the placement regulations and the examination regulations, the provisions of the examination regulations shall take precedence.

## Section 2

#### Goals of the Practical Module

The practical module is a voluntary component of the degree programme. It enables students

- to review their motivation and choice of profession and to gain ideas for the further course of their studies;

- to become acquainted with the specific demands and options for action in various fields of legal work;

- to engage in specialised legal problems and to apply knowledge and skills already gained in the degree programme and based on theoretical reflection.

#### Section 3

# Scope, Duration and Organisation of the Practical Modules

(1) The practical module may be recognised in place of a compulsory elective module (module 5 civil law or module 6 criminal law or module 7 public law. It comprises a total of 08 ECTS points (200 hours) of which 150 hours are to be performed as on-site hours at the placement institution and 50 hours should be taken into account as hours for independent study (preparation or follow-up).

(2) The placement should be completed in a law firm or in the legal department of a company in Germany.

(3) The dean's office (Erasmus Office) is responsible for coordinating the practical module. The Erasmus Office shall facilitate individual placements; suitable candidates shall be selected on the basis of their average mark and outstanding language skills. Individual students do not have a right to be placed in a placement. The decision lies with the institution offering the placement; that institution selects students for the placement based on their abilities (marks, language, other qualifications).

(4) If a placement not facilitated by the Erasmus Office is to be recognised, the agreement of the Erasmus Office must be obtained before beginning the placement.

(5) The placement should mainly be completed outside of the lecture period.

# Section 4

## **Entry into Force**

These placement regulations shall take effect on the day following publication in the official bulletin of Gottfried Wilhelm Leibniz Universität Hannover.
